#### Soviet strategies in Southeast Asia

In particular, Leszek Buszynski examines the rivalry between the Soviet Union and China, Soviet presence in Vietnam, and the responsive efforts of surrounding regions towards collective security. U.S. policy in the region is a key consideration,

particularly in terms of American attempts to placate China and encourage Japan to assist in the defence of the region. With a concluding assessment of regional trends and possible outcomes, this is an important and valuable work for students and scholars with an interest in the history and politics of international diplomacy in Southeast Asia.

#### The Soviet Union in Southeast Asia

This memorandum considers whether Soviet foreign policy in the ASEAN countries has been a success or failure. The author contends that after Vietnam invaded Kampuchea with Soviet support--and the ASEAN area assumed greater importance to Moscow than ever before--whatever influence the USSR had in ASEAN capitals was negated. ASEAN countries forcefully have opposed Vietnamese and Soviet policy toward Kampuchea and the refugee problem, and indirectly have supported China. The author believes that Soviet strategy to contain China requires at least ASEAN neutrality, and that Soviet moves to reverse current trends can be expected. (Author).

## Asia In Soviet Global Strategy

Gorbachev's major speech at Vladivostok on 28 July 1986 signalled an increased awareness by the Soviet Union of the importance of the Asia-Pacific region. Subsequently there have been significant changes in Soviet foreign policy, paralleling the programme of wide-ranging internal reform and imparting a new look to the USSR's international image. The aim of the present work is to chart the development of Soviet policy towards the region since the start of the Bolshevik regime, with whether there was any pattern or consistency in that policy. Concentration on Soviet activity in a particular part of the world might also serve to throw further light on the much discussed question whether Moscow's policies have in the past been conceived in ideological terms (and therefore in some measure pre-determined) or whether they were truly ad hoc, ideology being used merely as justification.

## The Soviet Union and ASEAN

#### Soviet Relations With South East

First published in 1992, this book examines Soviet foreign policy towards Southeast Asia in the context of the transformation of the perestro-ka era in the Soviet Union. The discussion begins in 1985 and ends in 1989 with the Soviet partial withdrawal from Cam Ranh Bay. Buszynski considers Gorbachev's effort to disengage from the Cambodian problem, the weakening of the Soviet alliance with Vietnam and the real effort to overcome old hostilities with growth areas in ASEAN such as Thailand and Singapore. This is a fascinating and relevant title, of particular value to students with an interest in Russia and the history of international relations in Southeast Asia.

#### **ASEAN-Russia Relations**

From the end of World War II down to the dissolution of the Soviet Union, the primary objective of U.S. foreign policy has been to prevent the expansion of communism. Indeed, that objective was directly embodied in the so-called strategy of containment, a global approach to the pursuit of U.S. national security interests that was first adumbrated by George F. Kennan in 1947 and later became the guiding force in U.S. foreign policy. At first, the concept of containment was applied primarily to Europe. It was there that the threat to U.S. interests from international communism directed from Moscow was first perceived, in the form of Soviet efforts to dominate the nations of Eastern Europe and extend Soviet influence into the eastern Mediterranean and the Middle East. Other areas of the world—Asia, Africa, and Latin America—were considered to be less threatened by forces hostile to the free world or more peripheral to U.S. foreign policy concerns. At least that was the view initially proclaimed by George

Kennan himself, who identified five areas in the world as vital to the United States: North America, Great Britain, Central Europe, the USSR, and Japan. Only the latter was located in Asia. By the end of the decade, however, the focus of U.S. containment strategy was extended to include East and Southeast Asia, primarily because of the increasing likelihood of a communist victory in the Chinese Civil War, which, in the minds of some U.S. policymakers, would be tantamount to giving the Soviet Union a dominant position on the Asian mainland. Added to the growing threat in China was the increasingly unstable situation in Southeast Asia, where the long arc of colonies that had been established by the imperialist powers during the last half of the nineteenth century was gradually but inexorably being replaced by independent states. The emergence of such colonial territories into independence was generally viewed as a welcome prospect by foreign policy observers in Washington, but when combined with the impending victory of communist forces in China it raised the unsettling possibility that the entire region might be brought within the reach of the Kremlin.

## Soviet Asian Strategy in the Brezhnev Era and Beyond

This study attempts to analyse 20 years of Soviet-ASEAN relations -- what it is; how it has developed; why it has taken the stated course. It begins with an examination of Soviet attitude towards Southeast Asian regionalism and its policies towards ASEAN. Key issues in Soviet-ASEAN relations are next explored, followed by analyses of Soviet relations with individual member states and how each of these in turn perceives the Soviet Union. The changes initiated by Gorbachev and how these have affected Soviet-ASEAN relations are then highlighted and finally, the future prospects of Soviet-ASEAN relations are evaluated.

# Military Basing and the U.S./Soviet Military Balance in Southeast Asia

In examining the economic and social reforms of Gorbachev's Soviet Union, the contributors to this new study provide a broad portrait of the state of current soviet relations with the countries of the Asia-Pacific region, the prospects for change, and the perceived role of the Soviet Union in that change. Leading established scholars and specialists from the countries of the Asia-Pacific region study this new Soviet phenomenon and evince a mixture of enthusiasm and apprehension about Moscow's new policy overtures to the region. Mikhail Gorbachev's speech in the Soviet Far East city of Vladivostok on July 28, 1986, was widely read and commented upon throughout East and Southeast Asia, and raised many unanswered questions: How much has the Soviet Union really changed? Will China, the principal target of Soviet overtures, respond positively and, if so, what will the implications be for the rest of the region? What do these sweeping changes mean for the region in practical terms? The Soviet Union and the Asia-Pacific Region considers these questions and offers insight and provocative commentary on the current attitudes of the many Asia-Pacific countries toward the Soviet Union.

# The Strategic Triangle

This study investigates the overall Soviet conception of non-alignment in the Third World and assesses Soviet policy in relation to this issue.

#### Bear Tracks in Indochina

Since the end of the war in Vietnam and the withdrawal of the American presence there, a marked realignment of power has taken place in Southeast Asia. The old rivalry between China and the United States has become a relationship of cautious rapprochement, while Sino-Soviet competition has been intensified by China's fear that the USSR will move to fill the power vacuum created by the U.S. departure. The United States no longer perceives a friendly Sino-Southeast Asian relationship to be as much of a danger to its security interests as it once did, but how that relationship develops remains of considerable importance to this country. In this book, Edwin Martin examines some of the principal factors in China's current relations with the Southeast Asian countries— China's domestic policies, Peking-oriented insurgency in Southeast Asian countries, the Overseas Chinese, trade considerations, the policies of third powers—and concludes that the newly emergent nationalism in Southeast Asia, coupled with Sino-Soviet rivalry, indeed diminishes the threat posed by a Communist Indochina and calls for a U.S. policy of encouraging stable relations in the area, both among the countries themselves and between them and the PRC. He asserts that a four-way balance of powerinvolving the United States, the USSR, the PRC, and Japan—will prevent a power vacuum in the area and will allow the Southeast Asian countries to develop their own strengths, both political and economic. It is thus to the advantage of the United States to encourage all steps toward regional cooperation; U.S. policy, Professor Martin concludes, should neither abandon Southeast Asia, nor attempt to dictate to it.

# Soviet Strategy Towards Australia, New Zealand and Oceania

An evaluation of Soviet efforts to penetrate the major regions in the southern hemisphere, concluding that success has been modest and continues to be costly. It is suggested that a world society could emerge based on socio-economic and political competition rather than conflict and arms races.

## Restructuring of Soviet Far Eastern Air Power

Since its inception as a state, Russia has been both a European and an Asian power. Although Russia today, as was true during much of its history, is torn by an identity crisis over where it belongs, its elites have never renounced Russia's vital interests in Asia and the belief that it should be recognized as a great power there. However, that belief and Moscow's ability to sustain it are now under threat, due, as Dr. Stephen Blank's thorough analysis informs us, to the ongoing failures of Russian policymakers to come to grips with changed Russian and Asian realities. At the same time, this aspect of Russian policy has been neglected in American assessments of Russia. This is a serious shortcoming, because, in Dr. Blank's view, Russia's Asian policies, viewed in their full breadth, are important signs of present and future trends concerning its behavior at home and in the wider world. Those policies are also significant as Asia's importance in world affairs rises. We ignore the threatening situation facing Russia, and Moscow's failure to adjust to those threats, only at our own peril. The growing concern over Russian arms transfers to China, a subject addressed in the study, is only one sign of unexpected negative trends that might work against U.S. interests if we continue to neglect Asian aspects of Russia's global behavior and policy.

#### Soviet Capabilities, Interests and Strategies in East Asia in the 1980s

The historiography of the Cold War has long been dominated by American motivations and concerns, with Southeast Asian perspectives largely confined to the Indochina wars and Indonesia under Sukarno. Southeast Asia's Cold War corrects this situation by examining the international politics of the region from within rather than without. It provides an up-to-date, coherent narrative of the Cold War as it played out in Southeast Asia against a backdrop of superpower rivalry. When viewed through a Southeast Asian lens, the Cold War can be traced back to the interwar years and antagonisms between indigenous communists and their opponents, the colonial governments and their later successors. Burma, Malaysia, Singapore, Brunei, and the Philippines join Vietnam and Indonesia as key regional players with their own agendas, as evidenced by the formation of SEATO and the Bandung conference. The threat of global Communism orchestrated from Moscow, which had such a powerful hold in the West, passed largely unnoticed in Southeast Asia, where ideology took a back seat to regime preservation. China and its evolving attitude toward the region proved far more compelling: the emergence of the communist government there in 1949 helped further the development of communist networks in the Southeast Asian region. Except in Vietnam, the Soviet Union's role was peripheral: managing relationships with the United States and China was what preoccupied Southeast Asia's leaders. The impact of the Sino-Soviet split is visible in the decade-long Cambodian conflict and the Sino-Vietnamese War of 1979. This succinct volume not only demonstrates the complexity of the region, but for the first time provides a narrative that places decolonization and nation-building alongside the usual geopolitical conflicts. It focuses on local actors and marshals a wide range of literature in support of its argument. Most importantly, it tells us how and why the Cold War in Southeast Asia evolved the way it did and offers a deeper understanding of the Southeast Asia we know today.

#### Gorbachev and Southeast Asia (Routledge Revivals)

The years 1900 to 1954 marked the transformation from an exotic, colonized "Far East" to a more autonomous, prominent "Asia Pacific". This anthology examines the grand strategies of great powers as they vied for influence and ultimately hegemony in the region. At the turn of the twentieth century, the main contestants included the venerable British Empire and the aspiring Japan and United States. The unwieldy leviathan of China, the European imperial holdings in Southeast Asia, and the expanses of the western Pacific emerged as battlegrounds in literal and geopolitical terms. Other less powerful nations, such as India, Burma, Australia, and French Indochina, also exercised agency in crafting grand strategies to further their interests and in their interactions with those great powers. Among the many factors affecting all nations invested in the Asia Pacific were such traditional elements as economics, military power, and diplomacy, as well as fluid traits like ideology, culture, and personality. The era saw the decline of British and European influence in the Asia Pacific, the rise and fall of Japanese imperialism, the emergence of American primacy, the ongoing struggle for independence in Southeast Asia, and China's resurrection as a contender for hegemony. Great powers shifted and so too did their grand strategies.

## U. S. Containment Policy and the Conflict in Indochina

# The Soviet Union, Challenges and Responses as Seen from the European Point of View

This monograph provides a timely assessment of the geostrategic significance of Asia-Pacific and offers as a thought-provoking analysis of the U.S. strategic shift toward the region and its implications, with several key points. First, Asia-Pacific, which covers China, Northeast Asia, and Southeast Asia, is a region with complex currents. On the one hand, there is an unabated region-wide drive for economic development that has been pushing Asia-Pacific forward for decades. On the other, this region is troubled with, aside from many other conflicts, unsettled maritime disputes that have the potential to trigger wars between and among Asia-Pacific nations. Second, on top of these mixed currents, China and the United States compete intensely over a wide range of vital interests in this region. For better or for worse, the U.S.-China relationship is becoming a defining factor in the relations among the Asia-Pacific nations. Third, the U.S. strategic shift toward Asia-Pacific is, as President Obama puts it, not a choice but a necessity. Although conflicts elsewhere, especially the ones in the Middle East, continue to draw U.S. attention and consume U.S. foreign policy resources, the United States is turning its focus toward China and Asia-Pacific. Fourth, in the mid-2000s, the United States and China made an unprecedented strategic goodwill exchange and agreed to blaze a new path out of the tragedy that often attends great power transition. Fifth, at this time of U.S. strategic reorientation and military rebalancing toward Asia-Pacific, the most dangerous consideration is that Asia-Pacific nations having disputes with China can misread U.S. strategic intentions and overplay the "U.S. card" to pursue their territorial interests and challenge China. Finally, territorial dispute is becoming an urgent issue in the Asia-Pacific.

## The Priesthood of All Believers and the Missio Dei

The priesthood of all believers is a pillar undergirding Protestant ecclesiology. Yet the doctrine has often been used to serve diverse agendas. This book examines the doctrine's canonical, catholic, and contextual dimensions. It first identifies the priesthood of all believers as a canonical doctrine based upon the royal priesthood of Christ and closely related to the believer's eschatological temple-service and offering of spiritual sacrifices (chapters 1-3). It secondly describes its catholic development by examining three paradigmatic shifts, shifts especially associated with Christendom (chapters 4-6) and a suppression of the doctrine's missional component. Finally, the book argues that a Christian doctrine of the priesthood of all believers should be developed with a Christocentric-Trinitarian understanding of the missio Dei. This suggests there are especially appropriate ways for the royal priesthood to relate to the Father, to the Son, and to the Holy Spirit. A canonically and catholically informed priesthood of all believers leads contextually to particular ecclesial practices. These seven practices are 1) Baptism as public ordination to the royal priesthood; 2) Prayer; 3) Lectio Divina; 4) Ministry; 5) Church Discipline; 6) Proclamation; and 7) the Lord's Supper as the renewal of the royal priesthood.

## The Gift of Infallibility

Infallibility is a deeply misunderstood idea, within as well as outside the Catholic Church. It remains a subject of great theological debate, especially regarding papal infallibility and the ordinary magisterium

of the Church. In The Gift of Infallibility, theologian James T. Oconnor clarifies the idea of infallibility. He provides a helpful translation of the celatio or official explanation by Bishop Gasser given at Vatican I, the Church council that defined the dogma of papal infallibility. #### Revelation

In this insightful, interdisciplinary study, Robert Sokolowski uses the methods of phenomenology to examine Christian religious beliefs, particularly the sacrament of the Eucharist. In so doing, he comes to terms with many theological and cultural issues raised by modernity. Although the Eucharist is the center of focus, other issues in Christian faith are also examined, such as the Christian understanding of God, Creation, the Incarnation, Redemption, and biblical Revelation. Sokolowski employs a method that he calls "the theology of disclosure," which studies the structures of appearance and should be distinguished from both positive and scholastic theology. He takes appearances as objective disclosures, not as mere psychological events. When discussing the Eucharist, he shows how it uses the form of quotation and how it draws on various temporal dimensions of human existence as it reenacts the sacrifice of Christ before the eternal Father. The author also considers how Christian belief differs from other forms of religion and from modern atheism. By demonstrating how the Christian understanding of God differs from other ways of understanding the divine, he attempts to show that Christianity is not simply one religion among many but the truth of religion. These deeper themes are explored as necessary contexts for the Eucharist, which could not be properly understood except against the background of the Christian understanding of God as eternal and as Creator and Redeemer. The author provides a comprehensive theological treatment of major issues in Christian faith and does so with categories that are appropriate to our present intellectual and cultural world. This study, which draws upon the work of many classical and contemporary theologians, especially Hans Urs von Balthasar, contributes significantly to speculative theology and to Eucharistic studies. In this book the author, relying on the research he carried out in Igboland, Nigeria, leads us to see the action of God's grace already active in the Igbo religious culture called Omenala Ndigbo before the coming of Christian missionaries and how these cultural values have prepared the people to receive the Gospel. But, as he points out, these cultural values on which the Christian message ought to have been built from the beginning were grossly misunderstood and neglected. The Igbo people are now mainly Christians. But because the Gospel has not yet become their culture, some of them have double allegiance to the doctrines of the Church and to the practices of Omenala Ndigbo. The author opines that to build the Catholic Church in Igboland on a solid foundation, the Eucharist must take the central place - since the Eucharist makes the Church and is the source and summit of the life of the Church. Thus the work, which uses the analytical and hermeneutical method known as inculturation,

is on Eucharistic Ecclesiology from an Igbo perspective and will be useful for the Church, both at the local and universal levels for self-understanding and renewal, ecumenism, dialogue and mission.
