The phrase "administrative law," as used in the United States, makes an imperfect distinction between
the procedures agencies use to make rules, set standards, and adjudicate and the substantive
content produced by those actions.
The distinction is imperfect because administrative law provides for judicial review of agencies' rules,
standards, and adjudicatory decisions, which may be found unlawful if their content is irrational or
their scope is beyond the law.
Moreover, administrative law, with the exception of some forms of adjudication, is not concerned with
agency decisions regarding internal personnel, organizational, budgetary, outsourcing, and similar
administrative matters.
All levels of government in the United States rely on some form of administrative law to regulate their
administrative activities.
